- a) on the Western side, a straight line between Tanjung Bidadari ($5^{\circ}49' \cdot 6N$, $118^{\circ}21' \cdot 0E$) to position $3^{\circ}32' \cdot 0N$, 118°
- b) on the South Eastern side, a straight line from there to position $5^{\circ}50' \cdot 0N$, $122^{\circ}31' \cdot 0E$, and thence northwards to position $7^{\circ}06' \cdot 6N$, $122^{\circ}31' \cdot 0E$
- c) on the Northern side, a straight line from there to Batorampon Point Light ($7^{\circ}06' \cdot 6N$, $121^{\circ}53' \cdot 8E$)
- d) and on the North Western side, a straight line from there back to Tanjung Bidadari.

Gulf of Aden

The area enclosed by the following boundaries:

- a) On the West, Longitude $45^{\circ} E$
- b) on the North, Latitude $15^{\circ} N$
- c) on the East, Longitude $57^{\circ} E$
- d) and on the South, Latitude $10^{\circ} N$.
