承保範圍(一)	<p>特別約定</p> <p>1. EXPEDITING EXPENSE</p> <p>This Policy shall be extended to pay for the reasonable extra cost of expediting the repair, replacement or reinstatement of property damaged by a peril insured, including overtime, night work and the extra cost of express or other rapid means of transportation. The Insurer's liability for such payment shall be the amount actually expended by the Insured for the reasonable cost of expediting the repair or replacement of the loss or damaged property that necessitated such expenses.</p> <p>This cover is in excess of the cover under "Extra Charges for Overtime, Night Work and Express Freight" and "Extra Charges for Airfreight".</p> <p>Limit of Indemnity : NT\$20,000,000.- for AOA/AGG</p>
承保範圍(二)	<p>2</p> <p>It is understood and agreed that if at the time any claim arises under section I. Material Damage of the Policy against loss of insured property for which such loss will otherwise be liable and indemnified by Marine Cargo Insurance of the Insured, the Policy will be of excess coverage to cover the excess of such loss over the amount paid from the Marine Cargo Insurance. If the loss amount paid by the Marine Cargo Insurance exceeds the deductible amount which would apply in the event of loss under this policy, it is also agreed such loss amount paid shall be deemed as the deductible applied under this Policy. Except for the above-mentioned excess coverage, this Policy shall be deemed as primary</p>
